AMENDED GENERAL ORDER

This general order is entered as an interim order pending the promulgation of new local rules. The effective date of this general order is May 15, 2000. This rule applies to all new bankruptcy petitions filed on or and after May 15, 2000 as well as to the pleadings and other papers to be filed in any pending bankruptcy case.

A. Rejection of Certain Deficient Petitions. The clerk may not accept a petition and must reject it if:

1. the petition is not signed with original signature(s) in all instances where original signatures are required;
2. the party filing the petition neither pays the prescribed filing fee with the petition nor files with the petition a signed application to pay the required fee in installments, if eligible to do so;
3. the debtor does not file the master mailing matrix and original signed Verification of Creditor Matrix with the petition;
4. the Statement of Social Security Number is not filed with the petition.

B. Corrections to Petitions, Schedules, Statements, Pleadings and Other Papers.

All errors, omissions, additions and corrections shall be made to petitions, schedules, statements, pleadings and other papers through an amendment as follows:

1. amendments to a petition, schedule or statement must be made in compliance with Local Rule of Bankruptcy Procedure, District of North Dakota 1009-1. The clerk may not accept and must reject any correction to a petition, schedule or statement not in compliance with the local rules of this Court;

2. pleadings and other papers may be corrected or amended by submitting a new document denoting in the title the document that is being corrected or amended. The clerk may not exchange a new document for one that has been previously filed;

3. pleadings and other papers that are missing signatures or captions will be stricken if not corrected in compliance with Section B(2) above within a reasonable period of time.
