The United States Bankruptcy Court for the District of North Dakota is pleased to announce the new Electronic Proof of Claim (**ePOC**) and Electronic Withdrawal of Proof of Claim (**eWOC**) filing system. **ePOC** allows easy and instant filing of proofs of claim electronically through our website at www.ndb.uscourts.gov.

The benefits of using **ePOC** and **eWOC** are:

- ✓ **ePOC** automatically creates Official B10 Proof of Claim form using the information you enter online. (*No paper form to complete and mail!).
- ✓ **ePOC** allows the attachment of supporting documents to the proof of claim. (**Reminder:** please redact social security numbers and financial account numbers (only last four digits should be used); date of birth (only year of individual's birth should be used); minor children's names and birthdates, if any).
- ✓ **ePOC** immediately files the proof of claim with the court.
- ✓ **ePOC** sends email notification that the proof of claim is filed with the court and you may obtain a file-stamped copy for your records.
- ✓ **ePOC** allows for amending proofs of claim.
- ✓ **eWOC** allows withdrawal of proofs of claim. (See ECF User Manual for important **eWOC** instructions).
